Footpath 419/24/1 – Following a site visit from the Countryside Access Team it was confirmed they cannot at present do anything to extend the footpath, however they will make further enquiries and if there is accrued or further evidence to substantiate CAT will respond.

#### Minute no- ROW21/17

Footpath 419/23/2 re surface water flooding and foul smells—Following a site visit from the Countryside Access Team it was confirmed no cause for concern. After writing to Environmental and following their site visit it was confirmed they

cannot assist in respect of this matter. Saturated, boggy ground can smell unpleasant due to the anaerobic breakdown of organic matter. Discussion took place and it was **AGREED** to review in the winter.

# **ROW10/18 Parish Footpaths**

- a) The clerk reported the 2018/19 footpath map does not correspond with the LMP schedule of maintenance. The administration has returned to CC. The clerk thanked Cllr Mrs Padley for her assistance in cross referencing these two items and has reported to CAT that 9 bridleways are not on the LMP schedule. They are subsequently sending the PC's report to CC who will correct the cutting schedule. The PC are awaiting the additional schedule. To note the Environment and Business Incident Team who originally sent the 2018/19 schedule and map are not registered in the CC directory.
- b) Complaints received with small public footpath access areas that require cutting:

Link footpath St Stephens Rd to Lingfield Polgooth Chapel – small area leading onto the gold footpath Walkway from Southdown Rd

A thank you to Cllr Mrs Ringrose who has strimmed the small area at Polgooth Chapel this week.

Discussion took place and Cllrs agreed these small areas should be cut as and when. Cllr Holman proposed the clerk obtain quotes from the two contractors. If it is within the clerk's delegated powers for expenditure and within the proposed budget to ask a contractor to carry out the strimming. As the PC is awaiting the revised LMP schedule the bridleway from Chapel Hill to Parramoor is severely overgrown, poses a small risk to the council and the clerk seeks permission to instruct AI/GHL to strim, sec Cllr Mrs Mitchell. All in favour. **Action: Clerk** 

# **ROW11/18 Digital Mapping update**

Cllr Holman confirmed the programme is nearly completed and his training will take place onTuesday. There are no issues and the mapping will show the map and photograph which can all be uploaded to a suitable website. The long-term aim will be to go live on line with the PC's website. To check the CC website and transfer the map. Excellent software which will eventually extend to Allotments and Trees. Cllr Holman will report back at the next meeting. No further expenditure is required.
