The Council's reasons for refusing permission for this development are as follows:

- Safe and suitable access has not been demonstrated, and cannot be demonstrated for the scale of development proposed. The access and highways infrastructure in the area is considered to be unsuitable for the scale of vehicle movements associated with the proposal. The path/byway over which access is proposed is substandard in terms of width, forward visibility and inter-visible passing. The access from the A3058 onto the Green is also of substandard width. The proposal would risk conflict between byway and highways users and there is insufficient land available to provide mitigation against these issues. The proposal would thereby be contrary to Policy 27 of the Cornwall Local Plan Strategic Policies 2010-2030.
- 2 The site is located in the open countryside and consists of a green field site bordered by hedgerows and trees that contributes towards the distinctive rural setting of the village and the character and appearance of the area when viewed from the Byway and Public Footpath. The proposal would see the removal of a section of hedge and trees and loss of the green open space to development. The site does not integrate well with the built up part of the settlement with only a small proportion of the site boundary adjoining the Trewoon Settlement Boundary and the majority of the site adjoining agricultural land and the byway. The proposal would thereby cause significant harm to the landscape character of the area and be contrary to policies 1, 2, 3, 9, 12 and 23 of the Cornwall Local Plan Strategic Policies 2010-2030 adopted 2016 and Policies 2 and 11 of the St Mewan Parish Neighbourhood Development Plan 2016-2030 adopted 2018.
- 3 The application fails to comply with the habitat directives in that there is no overriding public interest for the proposal and there would be a disturbance to foraging and commuting bats. The application is therefore contrary to policy 23 of the Cornwall Local Plan Strategic Policies 2010-2030 adopted 2016; paragraphs 174 and 175 of the NPPF 2019; the Conservation of Habitat and Species Regulations; Circular 06/2005 and Policy 3 of the St Mewan Parish Neighbourhood Development Plan 2016-2030 adopted 2018.
- A Section 106 legal agreement has not been entered into to secure the necessary affordable housing, public open space and education contributions to mitigate harm from this proposal. The proposal would thereby be contrary to Policies 3, 9, 13 and 28 of the Cornwall Local Plan Strategic Policies 2010-2030 (adopted 2016) and the advice within the National Planning Policy Framework.
