# **WELCOME**

#### to the Summer 24 edition of the St Mewan Parish Council Newsletter

In May 2023 I attended The Goffin in Polgooth for the unveiling ceremony of a granite plaque to commemorate the coronation of King Charles III which was carried out by the Lord Lieutenant of Cornwall, Colonel Edward Bolitho OBE who also planted an Apple tree. After the ceremony and judging of the children's events the Polgooth Garden and Community Group provided a buffet lunch at the Polgooth Inn. We were blessed with a hot sunny day, and everyone had an enjoyable time.

The Queen Elizabeth II Community Garden in Trewoon secured funding in the first round of the Good Growth Fund and was completed during the summer of 2023. The project had been in the early planning stages when the Covid lockdowns halted the process and the Parish Council had picnic benches ready to be put in place. In 2022 we purchased a bench to commemorate the Late Queen's platinum Jubilee, all this seating is placed to overlook the garden which boasts sensory planting (to attract pollinators) wildflowers, fruit trees and adult exercise equipment. The garden will be opened officially by Colonel Sir Edward Bolitho KCVO OBE Lord Lieutenant of Cornwall.

The Parish Council continues to support community groups throughout the Parish, for example Polgooth Community and Garden Club and Three Bays Wildlife who together are working to enhance The Goffin, The Soroptomists who run the very successful Memory Cafe in Sticker and the many other groups and volunteers who work selflessly to help others. It facilitates volunteer awards every year, provides prizes of shopping vouchers for the Christmas decoration competition, and has a grant programme to assist charities and events in the Parish. The Council values the hard work of those who organise events which bring so much benefit and pleasure to so many people, long may they continue.

St Mewan Parish Council works hard to benefit the residents of the Parish, the most recent benefit being to grant permission for the fish and chip van to operate in Sticker car park once a week which appears to be a very popular decision. Although it recognises that it is not possible to please everyone all the time, it endeavours to do its best and it is worth noting that without a Parish Council none of these things would be possible.

The Parish Council are always appreciative of volunteers

coming forward wanting to make a difference in a place where they live which ultimately creates a positive impact on the local community, therefore the council would like to recognise these people through the Community Volunteer Award evening. Thank you to The White Pyramid, The Hewas Inn and The Polgooth Inn who continue to sponsor a meal voucher. The Parish Council also donates £25.00 to a chosen charity of their choice.

On Remembrance Sunday I was privileged to lay a wreath on behalf of St Mewan Parish Council at the service at St Mewan Parish Church. It was a very moving experience and as we stood in the rain listening to the names of those from the Parish who had given their lives in the course of two world wars, I reflected on the fact that because of them and many, many more I have been lucky to live the life I have had with the freedom to express myself, however now in the 21st century with the internet and social media platforms freely available it is deplorable that it is often used as a vehicle for bullying and hate, targeting all levels of society from members of parliament right down to schoolchildren.

After a long dry summer in 2023 with a hosepipe ban and dire warnings of water shortages, Mother Nature has responded by providing much more water than many of us wanted this winter. 
#### **VACANCY**

## **PLANNING**

#### Planning Report by Chair Cllr Mrs Tarbox

The last year has been busy on the planning front. The Council worked with Cornwall Council to produce a Design Code which went out for public consultation towards the end of 2023, it is now progressing through its final stages. Design codes are part of the new planning regulations which are in the process of being introduced and there will also be one for the whole of Cornwall. Another new document which will become part of the planning process is a Neighbourhood Priority Statement, this will sit alongside our Neighbourhood Development Plan. The Council has applied to Cornwall Council to be part of a pilot scheme to become one of the first parish and town councils to work with Cornwall Council and produce a Neighbourhood Priority Statement for St Mewan. In due course residents of the Parish will be consulted on this document.

Planning applications continue to be submitted and The Council has its opportunity to comment on each one, taking into account planning rules, location and the Neighbourhood Development Plan. Most are straightforward but the occasional one is contentious raising a lot of public concern. Others do not comply with the plan and some developers try hard to obtain permission to build full market value houses on sites which should be either totally or predominantly reserved for affordable housing or on sites which are in open countryside and not compliant with the NPPF or the Cornwall Local Plan.

New developments are rather like 'marmite' but St Mewan Parish Council will always endeavour to ensure that they



comply with the Neighbourhood Development Plan.

One planning application which raised many local concerns was the application for The Paddock, St Stephens Road, Sticker for a gypsy site for six caravans, day rooms, touring caravans, plant room and other associated works. The objections covered the location of the site, harm to the landscape, access on the brow of a hill on a National speed limit road, noise, parking etc. Cornwall Council were minded to pass the application but St Mewan Parish Council decided that it should be called in to committee.

On Monday 8 April 24 the application went to the Central Planning Committee for a decision. There were three speakers against the application, John Kneller, former Chair of St Mewan PC, who spoke on behalf of the residents, Cllr John Vine who presented the objections for the Parish Council and last but by no means least, our Cornwall Councillor Michael Bunny. These three speakers presented the objections, clearly, concisely, and robustly and I am delighted to say that democracy and common sense prevailed, and the committee was unanimous in the decision to turn down the application. I am sure that I speak for the residents when I thank them for their time and effort in taking it to committee.

The Council is fully supported by our Cornwall Councillor, Michael Bunny, Clerk Wendy Yelland, Deputy Clerk Amanda Kendall and I thank them for their hard work.

#### **PLAYING FIELDS**

#### Cllr Johnathan Spencer, Chair of Playing Fields

The Parish playing fields have once again proven to be valuable assets to our communities over the past year; many of the green spaces formed venues for aspects of the King's Coronation Celebrations and other events.

Any group that wishes to use our amazing spaces for events should get in contact with the Parish Clerk.

During the year all the Parish play areas have had some equipment replaced, bringing them all up to a high standard.

In early Summer, Trewoon Playing Field took delivery of a new spring rocker as well as both junior and toddler swings. Unfortunately, delivery took longer than anticipated as the courier company went into administration with our equipment on board! Subsequently our contractor had to order new, as all the courier lorries were grounded.

As part of The Queen Elizabeth II Memorial Garden in Trewoon, adult gym equipment has been installed which is proving popular.

Lastly and at the request of residents, new football goals have been purchased however these are currently in storage as the maintenance team await drier weather before installing. Lower Sticker has seen a new springer installed whilst the stationary roundabout has been removed. The area will now be made trip free, and a bench installed.

In an attempt to do away with muddy puddles, safety surfacing has been installed under the basket swing in Sticker Activity Park. The ever popular skate ramp and zip wire have both had a major overhaul and are looking so much better. The embankment slide has also been refurbished to such a high standard it now looks like a new slide! Lastly the climbing frame has had a coat of paint and is now a lovely patriotic gold and black.

Finally, in Polgooth the stationary roundabout has been removed, along with the cycle stand, as it had rotted. A new bike stand will be relocated at the other end of the pump track. Grant applications are now being applied for to allow replacement swings in this area.

I would like to thank the playing field committee and all members of the Parish Council for their support. I would also like to thank the Clerk and Deputy Clerk for their hard work and guidance over the last year.

# **FINANCE**

## ST MEWAN PARISH COUNCIL INCOME & EXPENDITURE 2024/2025

The Council formally approved the annual budget of £108572.00 for 2024/25 and has been set in accordance with statutory requirements as set out in sections 39 to 51 of the Local Government Finance Act 1992 and the Accounting and Audit Regulations 2015. The setting of the budget has taken any likely changes in costs and income associated with the running of the Parish Council into consideration and has been prepared in accordance with key principles of prudence and transparency, and the levels of balances, reserves and contingencies within the budget, are adequate. To parishioners this is an increase of 2.18% which equates to an additional cost of £1.82 per year on a Band D property from year 2023/24 as you will see indicated on your Council Tax Bill under Parish Precept.

The Parish Council has no valuable budget income other than very small streams coming in from the allotments and a grazing

licence. The service level agreements go towards verge and footpath cutting; however, the council are committed to continue delivering the essential services required to continue enhancing the surroundings and deliver new projects outlined in the Council's Action Plan some of which are eligible to be funded through the Community Benefit Fund.

Below is a snapshot of committed budget expenditure for 2024/2025. Apart from the management of the Parish, Grants and Public Works Loan we maintain everything highlighted in the orange bar below, appointing contractors who are qualified, certificated and have the required public liability in each specialist service area of the parish. This ultimately saves the council having to budget and purchase high end equipment with the added costs of associated expenditure all of which reflects in the parish proportion of your council tax bill.

**General Fund** The 2024/25 budget includes a contingency provision to provide adequate resources to protect against any unforeseen spending pressures or possible future funding cuts. The current level that was forecast as at the 31st March 2024 going into the new financial year was at minimum of 5 twelfths of the annual expenditure.

**Ear Marked Reserves** are held for a specific purpose and as of 31st March 2024 stands at £39240.53 including an ear marked fund for additional services that may be devolved from Cornwall Council.

**Ring Fenced Reserves** cannot be used for the purpose of budget/precepting and as of 31st March 2024 stands at £78493.00

We are working towards 'Quality Status Award' and will seek to reconfirm to residents that we operate at the forefront of best practice, in governance, community leadership and council development, through aspiring to achieve in the tiered awards.

# RIGHTS OF WAY

#### Rights of Way Annual Report by Cllr Vine 2023/2024

The Parish Council has resolved to commit to the Local Maintenance Partnership again this year 24/25 which means that we sign an agreement with Cornwall Council to undertake the devolved service to cut the majority of Gold Footpaths twice a year or some only once and Silver Footpaths at the council's discretion. This footpath cutting service is undertaken by the Parish Council contractor and the Parish Council receives a small grant which assists the Parish Council budget when setting the precept. We are responsible for cutting 12,649 metres of footpaths in addition to some identified stiles and gateways.

For most Parishes, the ideal time for a first cut would be at the beginning of the season during May/June. For many paths this would be sufficient. A second cut may be required later in August/September if vegetation growth starts to encroach on the path. Note that vegetation growing from the side and overhanging the path is legally the responsibility of the landowner and the Local Maintenance Partnership is a budget to be used for what it is meant for -footpath maintenance and cutting. The Parish Council are also part of the Enhanced Footpath Scheme which is an agreement with Cornwall Council that if a footpath/bridleway signpost is found to be rotten or missing and requires renewal, Cornwall Council will supply the signpost and the Parish Council will undertake the cost of the labour to install.

We have currently renewed:

- Bronze Footpath 419/11/1 off St Stephens Rd, Sticker
- Gold Footpath 419/16/1 end of Bosinver Lane
- Gold Footpath 419/39/1 off Ricketts Rd Polgooth We are awaiting a location from the Countryside Access Team to reinstall this Gold Footpath signpost.

Monitoring of 419/34/1 which runs from the Scout Hut in Sticker to the road to the North of Glenleigh Park has been cleared and cut back, however there is an area at the bottom which still remains very boggy. This is being monitored by the Countryside Access Team at Cormac and we are hopeful this bridleway will form part of their future capital expenditure programme for remedial works.

Bronze Footpath 419/33/1, the footpath running from Hewas Water North across the bypass, is now incomplete and we are awaiting confirmation of an extinguishment of it as a complete path, as it cannot be accessed from start to finish because of a break where it crosses the bypass.

The Parish Council are delighted that capital re-surfacing works took place on Bridleway 419/14 off Trelowth Rd,

Polgooth. Thanks to Cornwall Cllr Michael Bunney for these well overdue resurfacing works.

There has been an issue with Bridleway 419/6 at Tyshute Lane where Cormac completed the work last year. Halfway up the lane there is a pipe that takes water from one side of the lane into a drainage ditch on the other side. The pipe was blocked which led to the water flowing down the lane causing it to erode. Clearance was undertaken in November 23. Unfortunately, it is continuing to block at times and Cornwall Cllr Michael Bunney has requested that the Countryside Access Team now investigates a preventative measure. I am sure Michael will keep us updated.

#### **PUBLIC RIGHTS OF WAY**

Public Footpaths - Only open to walkers.

Public Bridleway - Only open to walkers & horse riders.

Byway Open to All Traffic – Open to all the above, plus cyclists, horse- drawn vehicles and motorised vehicles.

Restricted Byways – Open to all the above EXCEPT motorised vehicles

Additionally, bats are important pollinators and can control pest insects for you and their 'guano' (bat poo ) is an excellent fertilizer for your plants. So having them around is great!



# St Mewan Parish Council operates an Open Grants Policy and can provide grants to external bodies.

#### Type of Grants:

- A Council Grant is funded, through the precept and has limited funds of £2000 available to assist community organisations for this type of grant. The council also makes small discretionary donations from this fund.
- Community Benefit Grant and Council Grant Awards in 2023/2024 totalled £7436.68
- A Community Benefit Fund Grant arises from the contributions for two wind turbines operating in the Parish at Higher Goonamarth and Blackpool. This grant can be considered for larger community projects.

# **HIGHWAY CONSULTATIONS**

# The Highways Department on behalf of the Local Authority are responsible for regulations on the Highway.

A Statutory Consultee is where there is a requirement set out in law to consult a specific body ie Parish and Town Council.

The Parish Council is not a statutory consultee in consultations carried out by Cormac on behalf of Cornwall Council, which is the Highways Authority, but the Parish Council may be invited to feedback on Cormac's initial proposals that will be going to the public. The Parish Council can then consider a collective response at an Ordinary Council Meeting once the consultation is live, where their views maybe taken into consideration alongside members of the public responding.

It is up to individuals to respond to consultations carried out by Cormac. If anyone has a issue with the way the Local Authority consults, then please contact them direct at

# **COMMUNITY ENGAGEMENT**

Sensory delight: The Lord-Lieutenant of Cornwall officially opens Community Garden in the Parish of St Mewan in memory of Queen Elizabeth's reign

The transformation of underused space was years in the making and the idea for this sensory garden came from the local community after public consultation.

The village of Trewoon is one of three in the parish, however due to a busy main road, a key transport route, it effectively cuts the village in two and therefore it consequently has an urbanized feel. Unlike the other two villages, Trewoon had no quiet areas, there was nowhere for the residents, including young people to sit and socialise, an important factor to help combat loneliness.

Richard Wallis, former councillor sketched out the garden's original design to take up a small piece of underused land, next to the play area.

The figure of eight resin path is both a symbol for Reiki healing and infinity - fitting for a garden designed as somewhere to connect and reflect. The pattern of the garden is also practical where young children can ride their bikes and scooters safely around it, while parents watch on, and part of the pattern to accommodate four pieces of permanent adult gym equipment to encourage physical activity.

The hurdle to its redevelopment after public consultation in 2021 was, of course, funding with the project estimated at around £70000. We had just a small amount of S106 to be used in the recreational land to go towards the project, so we were delighted when the Local Authority launched Cornwall's Good Growth Fund Round 1 in September 22.

It was certainly a challenge for Amanda, Deputy Clerk to submit the application and for us to meet the criteria initially required, to complete the project by March 23.

Wendy, Parish Clerk, "It was so worth it, and we successfully secured a generous grant award of £60,000 in March 23 and relieved with an extended deadline"

Three separate contractors were re-engaged, starting in July 23 and the garden was finally completed in September 23.

Seeing the garden brought to life from those early sketches makes all the effort worthwhile as we now have the most sensory delight with picnic benches to sit and admire the beautiful plants and selected herbs bordering the paths, fruit trees planted, and the Darley Oak will eventually stand proud edged with an abundance of wildflowers - all to calm the



senses and attract wildlife.

We felt privileged that the Lord Lieutenant accepted the parish council's invitation to officially open the garden on the 11th of April 24.



The Lord-Lieutenant of Cornwall, Colonel Sir Edward Bolitho **KCVO OBE expressed** "One of the great strengths of Cornwall is this community spirit we have. That sense of community is embodied in this garden. Trewoon is well ahead of the curve in opening this Memorial Garden. Our late Queen's former private secretary, Lord Robin Janvrin, is heading a national memorial and legacy programme and looking for more initiatives exactly like this. I'm delighted to be here opening this garden and, in my own small way, helping foster that sense of community spirit."

The Parish Council are now working towards collaborating with The Cornwall Bicycle Project CIC - Community Cycling for everyone. Balance ability sessions are for small people starting out on their cycling journey from 2.5 to 5 years. To encourage grass gym groups and yoga sessions with instruction, and residents who may like to care take the garden.

The annual Vintage Rally has once again attracted an impressive turnout, with organisers optimistic that this year's event may set a new attendance record. The event's growing success is a testament to the support of dedicated volunteers from across the community.

This year's rally was more than just an impressive display of vintage tractors, cars, and motorbikes - it was a true celebration of Cornish heritage. From showcasing the region's finest food and farming to spotlighting the talents of local crafters and entertainers, the event offered something for everyone.

The three-day affair featured highlights ranging from sheepdog trials to a fun dog show, where the county's cutest canines took centre stage. "The event was bookended by live performances. Cornwall's much-loved comedian Johnny Cowling, along with Jailhouse, opened the show on Friday night. "It's one of only 11 left worldwide," said Peter Bradford of Trewoon, the car's owner. Peter, who acquired the vehicle in poor condition in 2021, has been gradually restoring it to its former glory.

The Mini Moke was a hit with celebrities like Twiggy, Lulu, and The Beatles, and appeared in numerous films, but it fell

out of favour when people realised how wet and cold the model is.

While the rally delivered a weekend full of excitement, its impact will extend far beyond the event itself, with proceeds benefiting three local charities; Children's Hospice South West, Cornwall's Blood Bikes and



Cornwall Air Ambulance's Heli2 appeal. The Rally Committee also plan to support some of the organisations in the Parish.







Kiley Pearce, Events Fundraiser attending the event for Children's Hospice South West, expressed her gratitude: "We're incredibly fortunate to be a beneficiary of this year's rally. #### THE GOFFIN, POLGOOTH

The Parish Council were delighted that the Polgooth Community & Gardening Club, who are a hardworking and enthusiastic group wanted to volunteer and caretake the wildflowers but also wanted to enhance The Goffin with maybe more planting and seating. The group fully appreciated that the Parish Council owns the land, therefore they initiated the public consultation enabling the residents to feedback any ideas before coming back to the Parish Council.

Asking for ideas was stapled in the centre of the Polgooth Times and delivered to every household in Polgooth. Residents

could either place their ideas in boxes which were placed in businesses throughout the Village or email the Parish Council direct.

43 households responded to the consultation with their ideas.

Top items:

Additional seating- 18, this is for more inclusive seating, so not restricted to picnic benches.

Paths- 14, Village Hall -12

Parking-11

Additional planting - this was subdivided as follows:

Trees- 7 Flowers- 10

Bee friendly- 3 Sensory- 2



The overall feeling from the responses were that residents agreed the area could be better utilised. There seems to be an overriding desire to have an area that not only incorporates a new Village Hall and parking but also helps nature and explains the history of Polgooth with trails and insect friendly planting. 4 responders required public toilets, a community shed was mentioned along with re-instating bbg area, sheltered seating was requested by 3 responders. 8 responders felt dogs should be permitted, this will be looked at again after any alterations have taken place.

Due to the 'overriding desire' for a new village hall, it was necessary that the parish council representatives shared those responses also with Polgooth Village Hall Trustees and Committee – termed in the deed 'The Management Committee of the Village Hall '.

They attended the July meeting of Polgooth Village Hall, to share the responses, and to find out whether the Management Committee of the Village Hall would be keen to move the Village Hall from its current location to The Goffin. The Parish Council representatives advised them that the Parish Council are only the 'key holder' and are unable to become involved in the management of the hall and that they would need to consult the wider community and then feedback to the Parish Council as the owners of the land. The Trustees and Committee who are all volunteers, felt that the move of a re-location seriously needed further investigation to ensure long-term financial sustainability and to make the hall accessible for everyone.

Building an extension to the hall will enable us to expand what we are already doing whilst also allowing greater access and inclusivity to the entire parish of St Mewan.

Our vision is to enable Trewoon Village Hall to become a community hub, creating a positive impact for the community. In order for this to happen, we are planning, and hoping to extend the already existing facility. This will enable a larger array of groups and activities to not only meet the needs of the village, but also build capacity for the current groups and volunteers. The extension will enable much needed expansion of local mental health provision, with the potential of inviting and welcoming local mental health groups to use the hall as well as working with such projects such as the Duchy Rural Health Partnership to help individuals realise their potential and

# **BOOK DEAL SEES LOCAL AUTHOR BRING ST AUSTELL** TO LIFE IN COZY CRIME!

At 77, Sticker resident and burgeoning author Christine McHaines has achieved a milestone many aspiring writers dream of - a fivebook publishing contract for her cozy crime series.

Christine's journey to becoming a novelist began in earnest after her retirement. Despite facing many rejections from publishers, her determination and passion for storytelling remained steadfast.

Reflecting on the moment she received her publishing news, Christine said, "I was returning from an appointment at Treliske with my husband when the email came in on my mobile. I was so shocked; I didn't say a word to him all the way home. I wanted to read it on a larger screen to confirm I was seeing it right first."

But Christine had indeed read the news right and the publisher not only wanted her initial manuscript, but the others she'd also written in her 'Quentin Cadbury Investigations' series. The latest to be published is set amid Cornwall's stunning scenery.

"I've always been inspired by Cornwall's natural beauty," Christine said. "Setting one of my books here was a given. Over the years, I've gathered notes and photos of places that sparked ideas. I've set some key scenes in the St Austell bay area. There's the Eden Project and Charlestown, but there are some less-iconic places too, like St Austell's leisure centre. I was keen to include some of those less famous places from where I live."

Christine's publisher, Erik Empson of The Book Folks, lauds her storytelling talent. "Christine's guirky characters and engaging writing style make these books easy reading and she wonderfully captures the essence of Cornwall in her latest novel."

The newest instalment, The Mystery on the Cornish Coast, follows young detective Quentin Cadbury and his partner, Wanda Merrydrew, as they navigate danger after a criminal they once caught escapes and forces them to embark on a dangerous adventure along the Cornish coast. It's available on Kindle. paperback and hardback on Amazon but signed paperback copies are also available at the independent bookshop, Hurley Books, in Mevagissey.

Christine admits achieving publication for her Quentin Cadbury Investigations series is a dream come true for her and she offers this advice to anyone else in the parish who is pursuing their own dream:

"Don't give up. I always wanted to be published so others could enjoy my stories. More importantly, I love to write, and that's what kept me writing for so long. My advice is to follow your dream and never give up."



#### **GUEST SPEAKER MR BARRY WEST** WHO ATTENDED THE ANNUAL **PARISH ASSEMBLY**

Mr West explained he is an historian and tries to bring history alive.

He found the grave of Marley in Cornwall after 10 years of research and is currently researching George Fox, who came to this Parish, the founder of Quakers.

Mr West is creating a memorial at Tregongeeves along with Loveday Hambly. He feels due to the Quaker movement we have a lot to be thankful.

Back in 1650 women did not have a voice but the Quakers believed everyone was equal. In July it will be the 400-year anniversary of George Fox's birth and he will be looking for funding, as presently he funds everything himself.

Mr West has the slate which is approx. 6 feet tall, it will have a Q at the top and the names of Loveday Hambly and George Fox.

The Chairman stated she felt it was a lovely idea and hoped that a lay-by could be incorporated on the site. This will be placed on a future agenda for Parish Council grant funding.

The unveiling took place on the 13th of July 2024.

# **VILLAGE HALLS ARE THE FABRIC** OF THE COMMUNITY!

Responsibilities of Committees and Trustees on Polgooth, Sticker and Trewoon Village Hall Committees in conjunction with the Parish Council and registered under the Charity Commission.

Registered properties as at the time of writing are as follows:

#### Polgooth 560, Trewoon 542, and Sticker 504.

Village Halls are the heart of rural villages and provide a lifeline for the local community. They are non-profit making but they can act as community hubs, organising fetes/events and they serve as meeting places where friendships are formed and strengthened, therefore the Parish Council will always endeavour to try and support Village Halls through grant funding for events or projects, which ultimately benefits the residents. They are unable to fund annual running costs, ie heating, insurance, roofs, windows, general repairs and renewals- the list can be endless!

The committee and trustees are responsible for agreeing the overall strategy and direction of the organisation and all give their time for free to support the Village Halls. The trustees are also responsible for controlling the work, management and administration of the charity on behalf of its beneficiaries. They are responsible for the financial management to ensure long term sustainability.

St Mewan Parish Council are only custodian trustees of the village halls which means the assets are vested in the custodian trustee and although the role of a custodian trustee holds the title to all the property of the trust, it is not involved nor can it be, in the day-to-day management of the trust as per the deeds laid out in statute, however the deed encompasses Parish Council

representatives to attend meetings. If there is no Village Hall Committee the keys come back to the Parish Council, as they can only be the 'key holder'.

The powers and duties of a custodian trustee are set out in section 4 of the Public Trustee Act 1906 - "The public trustee shall not accept any trust which involves the management or carrying on of any business, except in the cases in which he may be authorised to do so by rules made under this Act, nor any trust under a deed of arrangement for the benefit of creditors, nor the administration of any estate known or believed by hint to be insolvent"

The trustees, committee and volunteers come from all walks of life and they all volunteer for the good of the halls and the Community they live in, so if you want to join a Village Hall Committee and give your time for free and get involved contact:

#### Will I receive any other support?

Parish and Town Councils are supported by the National Association of Local Councils, through the County Association. The Association is there to offer legal advice, training and general support to all its members.

# **ANNUAL REPORT 2024**

#### MICHAEL BUNNEY Cornwall Councillor for St. Mewan. Grampound, St.Ewe, Pentewan Valley

I hope everyone has survived the terrible winter. I have reported many flooding issues and pot holes. Some have been resolved and other sections we are still pressing for work on

I have been very busy with planning issues and am pleased to report we have had a recent success in persuading the central planning committee to unanimously refuse the St.Stephens Rd application. Well done to the parish council and local residents for speaking so persuasively.

#### Community events/projects

I continue to attend as many community events as I can and was delighted to speak at Polgooth Ladies Group last week on the history of Cornish women. I also attended Sticker Memory Café to say a few words and support them following the community chest grant I gave them. I also helped open Trewoon Community Hub this month and delighted we have so many strong community groups. I do all I can to support our community activities and here is a quick overview of other events I have supported.

St.Pirans Day was on the 5th March and I am helped organise the St.Austell Festival on Saturday 2nd March, with events across the town centre and the parade at 1.30pm. We also organised traditional Cornish singing on Gorran Haven Beach and a Cornish breakfast in the village hall afterwards. It was lovely to see some St.Mewan and St. Ewe residents join us. Gool Perran Lowen!.

I met with local historian Barry West, who is leading a memorial project on the Quaker Cemetery at Tregongeeves and the life of Loveday Hambly. We are aiming to erect a memorial and wild flower garden to mark this important historic site. I am delighted Barry is coming today to speak to you.

I have contacted the Lord Lieutenant, who has agreed to join us to open Trewoon Queen Elizabeth 11 garden on 11th April

I spoke to Grampound WI for the Centenary and Sticker WI joined us.

I donate all funds from these talks to local charities and will be handing all donations to St. Austell and Truro food banks over the winter.

It was lovely to run assemblies on Cornish history for St.Mewan School. The children were brilliant (as were the staff) and knew lots about local history. I also speak regularly at Gorran School on local

I am also opening the St. Marks Flower Festival in Sticker in June.

Applications for my community chest will hopefully reopen at the end of April (depending on council budgets), so please encourage any groups to contact me to apply for a small grant, around £200.

I chair the White River Community Project and we have drawn up plans for nature recovery, flood mitigation and community environmental protection. We are working towards £40k of funding and have secured a commitment to provide £20k already.

I have written to Cornwall Community Land Trust to ask them for a speaker to come to speak to the parish council about land trusts. I am waiting for them to reply.

#### Roads, drains etc

I received many reports from residents about road problems and flooding and reported these to Highways.

We have secured agreement for a pedestrian crossing over the A390 to make it easier to cross between Higher Trewhiddle and St. Mewan. I submitted this application to Highways and we pressed for better lighting and signage.

It will be constructed by March 2025

At St.Mewan School, the line repainting and additional small section of waiting restrictions has been agreed as a possible community network highways scheme and will go out for consultation later this year. This has been requested by the school for many years to improve traffic flow and I submitted an application for it.

The community highways budget has no money left now. Highways have assessed all the schemes, including the ones the parish councils submitted and have them on a waiting list. But, all highways schemes will need to be resubmitted after May 2025 now, if a budget is agreed after then.

Polgooth to London Apprentice patching has been done and is a lot better. Cormac has confirmed the road will be closed in June for surface dressing to be applied to seal the road surface. They do this in the April to Oct months usually, to allow the dressing to fix properly. Following requests from Trewoon residents I contacted the transport team and got the bus stop moved in Trewoon next to the bus shelter, which obviously makes sense. This was appreciated and folk can now stay dry whilst waiting for the bus.

Resurfacing of the Trelowth bridleway has been completed and this is a major improvement. I have received many messages of thanks from residents. We have been pressing this for the last 2 years and residents have tried to get this done over the last 60 years.

I have met the area steward to look at flooding on Cooperage rd, Trewoon and he is submitting a work request for next financial year

The next 20mph meeting is on 10th June and the parish councils will be invited to consider further areas for the next phase of the 20mph zones. This will be the beginning of the consultation, but it would be helpful if the parish council could have a view on which areas you would like to be considered e.g. Sticker, Trewoon etc

#### Planning.

I am involved with many planning enforcement cases, especially at Meadow Lakes, Hewas Water and will continue to work closely with the parish council on planning applications. I called the St.Stephens Rd, Sticker application to committee in April and we won a unanimous refusal. The certificate of lawfulness at Meadow Lakes has also been refused this month. I will always back up the parish's view. I will always support your decisions and think it is important applications are in line with your neighbourhood development plan. I always stress this to developers who contact me and advise them to meet with the parish council and me if they are considering applications. I am very happy to support you and take any major applications that you are concerned about to planning committee

I continue to work hard as your Cornwall Councillor and have met many residents to help.

# **POLICE REPORT**

#### Annual Police Report 2023/2024

POLICE

The past year has been incredibly busy for St Austell Police, with major incidents, significant events and high-profile VIP and Royal visits to contend with.

Staffing wise, Inspector Ian Jolliff has moved on to a new Detective Inspector role and has been replaced by Inspector Matt Trevivian. Matt may be a familiar name to some of you as he was a previous Neighbourhood Sergeant at St Austell, so has a good working knowledge of the area.

The neighbourhood team has been strengthened by the addition of 2 new Police Officers, taking our team total to 1 Sergeant, 9 PC's, 7 PCSO's and 3 Tri-Service Safety Officers. The team is split into 3 sub teams to ensure continuity and to enable the officers to form relationships with the people within their communities.

The officers covering the St Mewan parish and wider area are:

The response teams are also seeing an increase in officers with 8 new constables due to start at St Austell before the end of May.

In regard to crime stats, I have looked at the previous year, in which there were 73 recorded crimes for the St Mewan Parish for 2022.

This was a 24% reduction from 2021.

For 2023, there have to date been 14 recorded crimes for the area, which is positive news in that if the same rate of crime continues, there will be another drop in recorded crime from 2022.

There are no particularly worrying crime trends to make you aware of, with the majority of offences being low level.

The neighbourhood team was involved in investigating a mini series of shed breaks in Trewoon last year which unfortunately did not result in any positive action due to a lack of evidence when it came to proving the involvement of the main suspect.

Anti-Social Behaviour reporting for the area also saw a drop of 13% for 2022. The team have been working hard to engage with partner agencies and other professionals to tackle ASB at the source and this has seen some positive results including deterring a group of young people away from crime.

The team would encourage all ASB to be reported via the usual 999/101 system, or alternatively via email if the incident is not serious or ongoing by contacting us via the Devon and Cornwall Police website or Crimestoppers which is anonymous.

All in all, the Parish of St Mewan remains one of the safest in the sector, although we would still encourage residents and partners to remain vigilant and report anything concerning to Police.

# IMPERSONATION SCAMS/ COURIER FRAUD \_\_\_\_\_

We ask for residents to continue to be vigilant of the scam in which residents are contacted by unexpected telephone calls from bogus callers claiming to be a police officer, bank or fraud department, as we have received a number of recent reports in Devon & Cornwall.

The fraudster may be able to confirm some basic details such as name and address and creates a sense of urgency and fear and tells the victim that their account has been subject to fraudulent activity, or similar, and will apply pressure to convince the victim to hand over their bank details, bank cards or withdraw cash, which may be then collected by a person/courier or asked to send the items to an address.

 Any police, bank or fraud department will never ask for your PIN or to transfer or withdraw money - If you receive a call like this it is a scam, please hang up and do not give any information.

- If you need to contact your bank, please wait at least 5-10
  minutes for the line to clear before making a call, or clear the
  line by phoning a friend/family member, or make the call on a
  different phone to the one you were contacted on.
- If you have already given your bank details over the phone or handed your card details to a courier, call your bank straight away - phone 159 to reach your bank's fraud department directly.
