P35/20 Public Participation

Mrs Maguire thanked members for allowing her to address the committee on planning application PA20/06915.

- To remain in the village with their young family who will benefit being part of a lovely community
- Important to be close to a dependant relative
- The new build will be in keeping with Trevu and other surrounding properties
- The build will be on the blueprint of the large garage, utilising the existing space and the design is respectful of the local street scene of Chapel Hill
- The nearest point of the new build will be in excess of 14m away from the converted Sticker Chapel on the opposite side of the road
- The build is within the boundary as shown on the plan
- The strip of land and hedge in question has been there for approx. 6 years and has never been an issue before. The land was previously used for fly-tipping and dog fouling; therefore, it was decided to maintain the land and make it aesthetically pleasing for everyone in the area to detract the anti -social behaviour
- Welcomes anyone who wishes to discuss the plans in order for them to have a better understanding of the proposed development

The applicant confirmed to Cllr Wallis and members the build is larger lengthways than the garage, the roadside hedge would be retained, and they would continue to maintain it.

Proposal Demolition of existing attached domestic garage for new detached dwelling **Location** Land Adjoining Trevu Chapel Hill Sticker St Austell

Applicant Mr and Mrs T & S Maguire

Grid Ref 980620 / 500900

Cllr Mrs Tarbox, Cllr Jannaway and the Clerk visited the site on Tuesday 22nd September 2020 and reported their findings to members.

- The ridge height of the proposed dwelling is in line with Trevu
- The property behind the new dwelling is higher
- The summerhouse being removed will create amenity space
- The new dwelling is being built further forward
- Existing access and parking are good
- The proposed new build is not in line with the dwelling behind
- Cornwall Council records were checked, and the strip of land referred to by other residents is not 'Common Land'

The application, plans and associated documents were viewed, together with the St Mewan Neighbourhood Plan. Wide range of discussion took place and it was **RESOLVED** to **SUPPORT** the application based on the following: -

- Complies with Policy 1 a) and e) of the adopted St Mewan Neighbourhood Development Plan
- A need for local people to support dependant relatives
- To retain hedge between the new build and The Warren

Note: Whilst mindful of the listed residential Chapel opposite it is considered there is no impact.
