 Application PA20/07939 Proposal Demolition of Former Printworks, Garage and clearance of site, construction of 2 new detached dwellings Location Polgooth Press Trelowth Road Polgooth St Austell Applicant Carnsworth Ltd Grid Ref 199613 / 50594

The application, plans and associated documents were viewed, together with the St Mewan Neighbourhood Plan. Wide range of discussion took place, and it was **RESOLVED** to **OBJECT** to the application based on:

- The application does not comply with Policy 1 a), b), e) and Policy 5 (CISI report embedded) in the St Mewan Neighbourhood Development Plan
- Is overdevelopment of the site
- Not in keeping with the local area
- Inadequate parking
- Demolition of substantial existing stone walls
- Polgooth Press is a key historic building listed in the CISI report
- The plans are not clear on access. In order to access the dwelling at the rear you have either got to go pass the first dwelling and then access through the garden or go up the hill and park just off the road which will result in a need to break through. The applicant has stated no new entrances will be formed.

The application, plans and associated documents were viewed, together with the St Mewan Neighbourhood Plan. Discussion took place and it was **RESOLVED** to **OBJECT** to the application based on:

- Scraping an entrance with a JCB and a dump truck 2 days before the 3-year appeal date expires does not constitute a substantial start to the development
- There doesn't appear to be proof of sending the commencement of works to Cornwall Council as requested by them in Jan 2019 asking the applicant to submit the information to gain approval prior to starting the development
- The development goes against the St Mewan Neighbourhood Development Plan as it is outside the development boundary
- Planning policies has changed significantly since the original application made in 2014
- The implementation of the St Mewan Neighbourhood Development Plan in 2016 2018 where details and arrangements of affordable housing has moved on dramatically in 6 years.
