Sticker Activity Park -Aerial Runway is out of action. Clerk has obtained a quote for replacement universal parts. To obtain quotation and lead-time on manufacturers parts. Report back at next meeting.

The clerk provided members with a quote for benches of exact design with the same supplier. The council are saving £1200 if they purchase 10. Total cost of purchase is £3350 plus vat and free delivery. Further costs are the concrete bases.

RESOLVED to purchase 10 Salcombe benches and **APPROVE** associated expenditure for securing benches. Expenditure from the Community Benefit Fund. Recommendation to Full Council. The clerk will try and obtain sponsorship again for installation of bases. Prop Cllr Spencer, sec Cllr Mrs Mitchell.

PF25/20 Allocation of S106 Contribution of £9424 to Off-site Public Space in Trewoon
