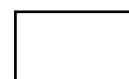

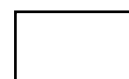

Requested refill salt bins – not completed. Apologies from Highways confirming their salt bins in the Parish were not showing on their identified list. They have now inspected the sites and updated their register.

Request to Highways for wildflower planting area to be included in the grass cutting agreement. Agreed in principle.

EDG1870 East Public Consultation, Proposal: Cormac Solutions Ltd on behalf of Cornwall Council is inviting comments on a proposal to change the extents of the existing 30/40mph speed limits at Truro Road, St Austell (A390). Awaiting a response from the Engineering Design Group expressing how the parish council are disappointed they have not considered their grave concerns on this proposal. Requested feedback on the level of support they have received. The clerk has passed all details to Cornwall Cllr Dick Cole who is acting on behalf of the Parish Council.

Cllr Mrs Sandra Heyward also disappointed as this affects her ward and has had a meeting with the design team who confirms they are partly governed by the DFT Regulations. Cllr Mrs Heyward expresses how the consultation should have been on moving the 30mph West past St Mewan School. There is a possibility funding could be available when the Local Transport Plan is renewed which would be part of large project funding and could identify a roundabout outside St Mewan School

OC170/20 S106 contribution from planning application PA19/06196, St Mewan Lane for off-site Public Open Space in Trewoon Recreational Ground.

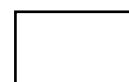
Wide range of discussion took place on the presentation by Cllr Wallis and shared on screen with members. Members agreed the draft plan created shows a Community Garden area with seating, wildflowers, a path, a sculpture of community choice and a dog walking corridor. There are concerns with the dog walking corridor and Cllr Mrs Padley feels strongly that the dog walking corridor must be fenced in a manner that walkers cannot access the play areas and Cllr Holman stressed how it will not become an official right of way. Observations from Cllr Kneller when on site was someone with a dog and child blatantly coming in the top entrance and entering the children's play area with the dog. Dog waste bins either end will need to be considered.

Cllr Mrs Tarbox requested this agenda item as she feels strongly that children are falling behind with their education during the pandemic through a lack of resources.

The clerk had spoken with the Head of St Mewan School Elaine Badger who confirmed there is an approximate shortage of 20 laptops and that she would be grateful for any small amount of assistance anyone can offer. Laptops need to have wi-fi, Word and a camera for virtual learning and support. All members unanimously agreed support is also required with the young in the community.

RESOLVED to grant the Friends of St Mewan £5000 from the Community Benefit Fund to purchase laptops. Prop Cllr Mrs Tarbox, sec Cllr Holman. **Action: Clerk.**

OC173/20 Traffic and Parking Issues in St Mewan Lane and Trelowth

Cllr Mrs Tarbox expresses concerns with parking issues in St Mewan Lane which is resulting in the road becoming increasingly dangerous having recently experienced an encounter with another vehicle when coming out of her drive. Members highlighted some solutions to alleviate the problems, however this would not be in the immediate future due to Traffic Regulation Orders required and the cost implications.

The clerk advised members she is still receiving regular emails with photographs of the inconsiderate parking in Trelowth layby. Cllr Mrs Sandra Heyward has also spoken with one of the residents. This is also an issue which cannot be resolved immediately. The clerk recommends that perhaps solutions for both parking issues could be considered for the next round of submissions on the Highways Budget Scheme and when council are able to, a visit to the resident from one/two Cllrs and the clerk. Cllr Holman and Cllr Passmore volunteered. It was

RESOLVED to visit when appropriate to. Prop Cllr Kneller, sec Cllr Holman. **Action: Clerk and Cllrs.**

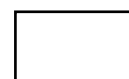

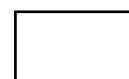
