Michael Bunney likes to keep up with Parish council business as he had done so in the last twelve months. If anyone wishes to contact me about any issues, I am available.

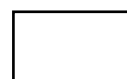

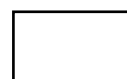

Cllr Wallis - the dog corridor could be reduced in width. Would require dog waste bins either end.

Commonality of feedback is vandalism. Was not aware of boggy land at the bottom, this could be overcome with land drains but its where we drain to. Further thought needs to be given. It was a quick and open design for comment and its excellent there are positive and negative comments with other ideas that have been suggested. The Chairman went to St Mewan School last week for a St Austell Voice press publication with head teacher Elaine Badger presenting a £5000.00 donation the parish council made to purchase additional laptops. Cllr Kneller took the opportunity explaining how the Community Benefit Fund through Clean Earth Energy payments of wind turbines can benefit the community. Elaine Badger would be delighted if children from the school could also become involved in the concept and design with the Community Garden especially with approx. 100 children who live in the village of Trewoon.

Cllr Wallis suggests extending the consultation until next month and to include Cllrs and members of the public in a working party group. The Chairman agrees with this suggestion; however, members need to be mindful that project delivery would be best placed in the forthcoming months.

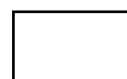

OC191/20 Average Speed Cameras Campaign in Trewoon

a) 10th February meeting Minute No: OC163/20

Mr Michael Bunney presented his detailed report on working towards average speed cameras in Trewoon. The clerk had previously circulated the report and Michel Bunney is happy to share the report with any member of the public.

BACKGROUND



Having attended St Mewan Parish Council meetings for over a year and has learnt that there are undoubtedly significant highways issues in Trewoon, especially with speeding on the A3058 through the village. The excellent social media campaign and petition evidences the local concern, and we should thank St Mewan Parish Council and Mr David Tregonning for their hard work. The community speed watch group, including key parish councillors have been working hard to stop speeding for many years and gather evidence and should also be congratulated. Their efforts and data collected will prove invaluable. Whilst walking around Trewoon in 2019 and 2020 I too witnessed speeding, despite the 30mph limit/flashing speed signs and have read of damage to property, injured animals and near misses that have presented a threat to human life. Older residents and children walking to St. Mewan School are put at particular risk and I agree with the Parish Council and local residents that urgent action needs to be taken and that average speed cameras look to be the only solution, which should be implemented by Cornwall Council via the Devon & Cornwall Partnership.

Cornwall Cllr Dick Cole has been very helpful on our behalf and has discussed data with the Highway Manager, who has provided a map. There is extensive data held across the council, police etc. Speed monitoring has taken place in six places on the road in recent years and this will all help with the feasibility assessment.

I have followed the success of Grampound's campaign to reduce speeding and spoken at length to Cllr Bob Egerton, who was instrumental in persuading Cornwall Council to put average speed cameras. In this paper I have outlined some key points of information that I have learned from Grampound's success and from my eight years of experience, as a parish councillor in Gorran and previous Cornwall Councillor. I have also spoken to senior Cornwall Councillor Dick Cole and Helen Nicholson; Community Network Manager for Cornwall Council and their advice has been invaluable. I hope these points will be helpful in continuing the campaign and achieving average speed cameras and other solutions for Trewoon.

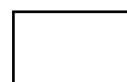
Further background on Grampound. A community campaign to tackle speeding began at least 20 years ago in Grampound, with slow progress to deliver the flashing speed visors and speed radar checking guns. Even these had little impact and recorded average speeds of 46mph. After at least ten years of persistent campaigning for average speed cameras, with a petition and community campaign they were installed in Jan 2020. The average speed cameras almost eliminated speeding overnight, with the effectiveness of the automatic number plate recognition. The total project cost was approximately £170'000 (includes road works, legalities, cameras etc) and the key challenge was to gather the evidence and persuade Cornwall Council/Highways to allocate these significant funds.

ACTION

Learning from Grampound and the advice I have received from senior councillors, there are three key elements of ACTION that could be followed.

1) REPORTING: GATHERING & COLLATING FURTHER EVIDENCE

Gathering further evidence to present an overwhelming case to Cornwall Council Highways is critical. MOST IMPORTANTLY residents should report speeding, especially those that cause any damage to property and threats to life to the police via 101. This is easiest to do online and will build a police picture of how significant the issue is. It is critical log numbers are noted and these are shared with the Parish Council. Police support and pressure for average speed cameras will be invaluable as we move forward. All speeding issues should also be reported to Cornwall Council online to Rachel Tatlow, the Highways Network Manager – email rachael.tatlow@cormacltd.co.uk and online via "Report a problem with a road" online form, on the council website. Emergencies causing immediate danger should be reported by phone tel 03001234222. It would be helpful if reports were copied to the Parish Council too, so a local record is kept of all reports to add weight and act as proof of the significant number of reports.



The data from speed readings from the speed watch, Parish Council mobile signs and police data are very important and need to be cross referenced and presented to Cornwall Council as evidence. The excellent work of the community speed watch group should continue and intensify if possible. I am happy to volunteer to help with this.

2) COMMUNITY & PARISH COUNCIL CAMPAIGN

The excellent work that is already happening needs to be continued, with the petition and press work. I would suggest a letter writing campaign as well, to detail personal experiences of speeding and individual concerns. Older residents and children's experiences, especially of the more vulnerable, need to be heard and will add significant weight to the case for average speed cameras. These letters should be sent to the next Cornwall Councillor and Parish Council clerk, so a dossier for submission can be prepared to submit. Letters could also be sent to political leaders e.g., our MP and lead Cornwall Councillors. They must also be sent to Rachel Tatlow, Highways Network Manager and we need to succeed in escalating Trewoon as a priority to the Service Director for Transport & Infrastructure. I would suggest the Parish Council resolve this evening to write a letter to outline the parishes' concerns in Trewoon, the urgent need for a feasibility study and their support for average speed cameras. It would also be appropriate to emphasise that a review of council policy on average speed cameras is due. This could be sent to the Service Director for Transport & Infrastructure, Nigel Blackler at Cornwall Council. Speed Watch posters/ placards could also be erected in residents' gardens e.g., SPEED CAMERAS HERE! It may slow down cars in the short term too.

3) DEVELOPING A FEASIBILITY STUDY

It is critical the Transport Department of Cornwall Council commence a feasibility study as a matter of urgency. This is on the current feasibility study schedule for the next six months and the new Cornwall Councillor, Parish Council and local residents must push for this and work on it together with Highways officers. In the feasibility study it is important to emphasise that most other traffic calming measures have been tried and proved ineffective, e.g., flashing lights, community speed watch, mobile cameras etc and therefore average speed cameras are the key option remaining. I expect additional crossing points will be raised as another alternative, but I don't believe these will have any significant impact on stopping speeding. Community views on this would need to be checked. I have experience of working on a feasibility study and am volunteering to help Trewoon. It will be essential that a rigorous and robust case is made by the next Cornwall Councillor to persuade Cornwall Council to commit the £170'000 to deliver the project. It is also crucial that we persuade the community network to prioritise the Trewoon scheme in their future allocated projects and we need to work with Helen Nicholson, the community network manager on this. It may also be essential that alternative sources of matched funding are identified by the community to speed up the delivery of cameras.

A feasibility study in Trewoon will be undertaken in the next 6 months as part of the Highways Budget Scheme request from St Mewan Parish Council.

Match funding will be useful.

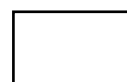

Sally Bourton is confident the village of Trewoon would want to get involved in Crowd Fundraising for this worthy cause.

The Chairman invites questions to Michel Bunney.
Wide range of discussion followed.

Michael Bunney is unsure if Grampound residents did any fundraising to assist in the purchase of average speed cameras and thinks as Community Fundraising wasn't mentioned in his research there quite possibly wasn't any. They did run a huge campaign which put pressure on the authorities. In theory, as local people, we should not really have to fundraise for critical services.

Members agreed with Cllr Mrs Tarbox that the A3058 is classed as one of the most dangerous roads in Cornwall.

Various funding pots can be investigated.

Cllr Spencer feels although it will be a long process with the feasibility study scheduled and shouldn't be funding or paying for what Highways should provide but a fair argument that the Community Benefit Fund for Trewoon could be used to benefit the residents who live in Trewoon.

The Chairman summarises from Micheal Bunney's report and proposes members **RESOLVE** to:

1. Support the Trewoon residents with this community initiative.
2. Delegated authority to the Chairman in conjunction with the clerk to write to Cornwall Council and Highways confirming St Mewan Parish Council will support the residents with the average speed camera campaign.
3. Offering St Mewan Parish Council's support.

Sec Cllr Mrs Tarbox. Carried unanimously.

Action: Chairman and Clerk

The Chairman re-instates standing orders. Sec Cllr Holman.

OC192/20 Wildflower Planting Phase 2

Issues with parking in Trewoon and damaged has occurred where planting has taken place. Cllr Wallis will discuss with the contractor on what could be erected to alleviate further damage.

Second phase analysis of approx. £50,000 over 5 years. Nine new areas for second phase. Large areas are more cost effective as the smaller areas need to be carried out by hand.

There is a small area in Polgooth where no ownership can be identified.

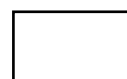

Resident in Sticker requests additional salt bin near to his home in Southdown Rd. The resident has offered to purchase and fill it.

The clerk advises members there is no problem to erect a new one but with the required permissions from Highways.

The Chairman **PROPOSES** the clerk writes to Highways confirming the location on the basis the resident is offering to purchase the salt bin and fill it, sec Cllr Holman. **Action: Clerk**

Highways will fill newly supplied salt bins once a year providing, they agree to the location placed. Polgooth resident request for salt bin supplied by the Parish Council to be relocated from Trelowth Rd to Polyear Close.

Although Cllr Holman lives in Polyear Close, and he was unfortunate to have slipped on ice on the 8th of January after a day of rain and one day of freezing temperatures Cllr Holman confirms this was a rare occasion for the chaos of vehicles skidding in Polyear Close and to fund salt bins and salt in all areas of the parish similar to Polyear Close would appear to be excessive for one day a year. No resident has contacted Cllr Holman expressing their concerns. The Parish Council need to be mindful not to create a precedence.

If no one is a willing volunteer as in Sticker and the parish council have to fund there and possibly other places for perhaps one or two days a year is this a worthwhile cost. It is disappointing had the cars waited for another hour the frost would have gone.

Cllr Spencer confirms this started a few years ago and met with the resident where three possible locations were discussed, and the resident was initially happy with siting it at the junction of Springfield Close leading to Polyear Close subject to the required permissions from Cormac. The resident has written to Highways over a number of years and to the Parish Council and whilst Highways choose to ignore the request perhaps the Parish Council need to consider a solution. Suggestions to maybe consider supplying bags of salt. Residents in Polyear Close were happily spreading their salt bags enabling access for the ambulance. Cllr Mrs Padley expresses it doesn't matter where a salt bin is sited it will be difficult to please everyone and living in places like Polyear Close keeping a bag of salt would be useful. The clerk confirms the new salt bin at the junction of Springfield has never been used, to consider relocating the salt bin to Polyear Close and write to Cormac outlining the valid reasons why it should be moved.

Cllr Spencer thinks perhaps after monitoring the use, it is in the wrong location and to re-locate in the concrete area (which belongs to Cornwall Council) in Polyear Close. Cllr Holman agrees with this recommendation moving forward.

It was

RESOLVED the clerk writes to Cormac requesting permission for the parish council to re-locate the salt bin to an area in Polyear Close and give the valid reasons why this should be included in the Cornwall Council winter schedule. Prop Cllr Spencer, sec Cllr Holman. **Action: Clerk**

OC195/20 Tree Management in the Parish

There needs to be clarity on how the Parish Council manage trees over permissive paths where there is no clarity who is responsible.

The clerk reported the advice from CALC would be for Cornwall Council to carry out a tree survey in the whole of the parish reporting on the general condition and a management plan. Pear Technology has software already mapped and should consider obtaining a sample.

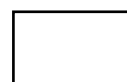
Cllr Mrs Heyward expresses a tree management is essential as Ash Die back is spreading into Cornwall. The Chairman feels a common-sense approach should be taken with continuing dialogue with property owners on tree issues and work towards a tree management policy.

The clerk advises a draft tree policy is started for insurance purposes and the chairman agrees this can then be advanced.

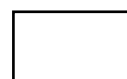

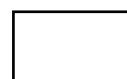
