The following comment has been submitted. St Mewan PC have grave concerns about Imerys HGVs using residential areas as rat runs. One in particular is St Mewan Lane in Trewoon which is often used by Imerys vehicles and its contractors. Cornwall Council has permitted more residential development in this lane which has increased residential traffic and pedestrians accessing the school and church. Any increased mix of residential traffic/children and other pedestrians/HGVs would be a lethal combination particularly as St Mewan Lane

Trewoon is a village divided by the A3058 which has been described as the most dangerous road in Cornwall. Any increase in Imerys HGV traffic will increase the dangers to residents who need to cross the road to access shops (Post Office, village shop, hairdresser, fish and chip shop) and other facilities like the village hall, playing field, children's playground and of course St Mewan School. Currently there is a local resident's campaign to press for Average Speed Cameras which has the full support of the parish council. Average Speed Cameras will help to reduce the impact on this road. As Blackpool Pit lies in the Parish of St Mewan it will inevitably create an increase in the volume of traffic, having an even greater impact on people's lives, therefore can IMERYS please consider and provide a contribution towards the Parish Council Community Benefit Fund which delivers projects and initiatives that has the interests of residents at the core. 0
