The agent is unable to attend Wednesday evening meetings and sends his apologies, however he would like to reassure the Parish Council that he and the developers would like to work with the Parish Council on this application and invites any questions the Planning Committee may have and fully respects the pre application protocol adopted by the Parish Council. Confirms that a public consultation will be held in Trewoon Village which gives Cllrs and residents the opportunity of viewing the



development plans, ask questions and complete a questionnaire. Cllr Mrs Tarbox Chair of Planning invited questions.

- Cllr Vine expressed its encouraging how a lot of work has been carried out on the pre application.
  - More details would be helpful on access during construction and once the site has been developed.
  - It would be useful if consideration could be given to some parking at Badgers Watch to alleviate the ongoing parking issues there.
  - The mix of affordable homes and costings as discounted sales are very popular.
  - To consider screening on the existing property side.
  - To consider a pedestrian access through onto Trevanion Lane which would create a safe passage for parents and children walking to school.

- No restrictions on rear fencing
- Provide parking spaces for individual houses and small areas of car parking which will alleviate regular parking on highways and pavements. This will also assist with deliveries etc to homes.
- How would we deal with differentiation between one house or a development site of 20 houses in the policy?
- Low-level letterboxes should not be considered in new builds.
- Hip roofs in new builds where they are considered in a position of dominance.
