The 'Chip Van' mobile fish & chips wants to start Thursday 18<sup>th</sup> January 24 from 5 -7ish in Sticker Car Park and would appreciate flexibility in this regard to stay later if trade warrants it.

It was agreed that the business would need to provide their own bollards. To meet on site in the first instance and suggest that some spaces in the centre run may work better. A social media post to confirm the council has agreed a 3- month trial period for the fish and chip van to provide a Community Benefit.

#### General

Hewaswater notice board has new locks fitted on one panel and all notice boards have new foam boarding inside.

FSGPA27/23 Freedom of Information request to Cormac. FOI- 101006818778Cormac response as follows:

Unfortunately, the Council does not hold the information relating to your request. This is due to the payment mechanism used for subcontracted work and consequently, Subcontractor's invoices are not provided in a way that record the specific information you have requested. The Freedom of Information Act only applies to information that a public authority already holds in recorded form at the time of a request. As we do not hold that particular piece of information, we are not obligated to create it.

Radar Class Study has been carried out on Burngullow Rd. The location of the pole was not ideal as this does not show a true reflection of fast-moving vehicles on a narrow stretch of road. Two residents are prepared to accommodate a pole on their land. Cornwall Cllr Michael Bunney suggested we go back to Highways.

**RESOLVED** to give delegated authority to Clerk and Deputy Clerk to purchase plants etc for the gateway planters. As Polgooth has no gateways to organise a painted tyre display for Polgooth. Cllr Vine showed the clerk an example. It was **AGREED** to display in a pyramid type/tyre display. It was also suggested we speak with Polgooth Community and Garden Club or local garden centre on type of perennials. Up to £1000 from the Community Benefit Fund. Prop Cllr Mrs Tarbox, sec Cllr Vine. **Action: Clerk and Deputy Clerk**.
