P97/24 Public Participation

Mr Mitchell spoke re application number PA24/02210.

- Permission in principle is sought for 4 dwellings
- Location plan edged in red with development already to the east, south and north
- View is that the site is 'rounding off' where the policy goes beyond the edge of the settlement
- To deliver 4 family homes related to the settlement

Mr Mitchell confirmed to the Chair that the 3/4 homes would be full market value.

Chair invited questions.

Cllr Vine An assumption has been made that because the planning officer has considered the 'rounding off' policy in other areas should not necessarily apply without due consideration to this application. Cllr Vine states that the planning statement provided it is being made clear that you are relying on 'rounding off' in other areas. Mr Mitchell confirmed that various conversations have taken place with Robin Watson – CC Highways, and it is their view they have no issues with the access on the number of properties being served.



Mr Mitchell confirmed to the Chair it would be the existing access used.

Mr Mitchell also has an interest Item 4 on the Planning Agenda and expressed it is just a change to composite weatherboard.

Grave concerns from resident Mr John Kneller when attending the Cornwall Council "Central Sub-Area Planning Committee Meeting" at County Hall with the Vice Chair of St Mewan Parish Council. At the start of the meeting the Members were informed by the Democratic Officer that they are no longer able to ask questions to Objectors, Supporters or Town/Parish Council speakers, however they are allowed to continue to ask questions of Applicants &/or their Agents. Local information is imperative to improve the decision-making process could have been clarified through questioning, but this route was unavailable to members. The following questions have been raised:

- 1. When and why was this decision arrived at?
- 2. Why was it just "dropped" into the meeting with no advance warning?
- 3. Does it represent fairness in individual applications when only one side of the discussion can be questioned?
- 4. Surely this approach erodes trust in the system and does nothing to promote the engagement of our local communities?



Cllr Vine confirmed this is not acceptable and flies in the face of democracy.

There cannot be a full detailed statement prepared for Central Planning in the time allowed to speak, it does not give any room for elaboration.

Local knowledge is critical for Cornwall Cllrs to request clarification when making an informed decision It was **RESOLVED** that the Parish Council writes to Cornwall Council's Constitution and Governance Committee where we understand a review will be undertaken. Prop Cllr Mrs Tarbox, sec Cllr Vine.
