## OC201/25 Kissing gates Trewoon Recreation Ground

The access on the left is not big enough, therefore we would need to remove vehicle access gate to accommodate or remove tree.

The wooden fence needs to be moved if vehicle access gate is moved, this fence is poorly erected needs raising with contractor. **Action: Deputy Clerk**

Cllr Spencer stated the footpath always went past Mount Pleasant, past their window. Cllr Spencer stated that the definitive map is incorrect, and the old ordnance maps show it through Mount Pleasant. The Clerk has sent this to Cornwall Council, but they are stating the footpath is not on Mount Pleasant and would need their permission to 'divert' the footpath. They are not understanding that the old maps show it in the correct place. It was suggested in the first instance to contact The Ramblers, also the British Horse Society. To continue to gather evidence.

The Committee were pleased with the responses, but the Committee felt that residents didn't appreciate there was no funds available to bring the Hall up to standard.

Need to arrange a survey to see how suitable The Goffin is building.

Cllr Davis congratulated Cllr Richards on obtaining that many responses.
