Footpath 15/1 – A resident sustained an injury on this footpath due to the presence of gullies, one of which had been constructed in concrete by a landowner to divert water runoff from his land. This issue was initially reported in March.

Following further complaints, the clerk contacted the CAT again via email and telephone. It was confirmed that a letter would be issued to the landowner on 9th May, instructing them to remove the obstruction within 28 days. The landowner has since complied, and the concrete gully has been removed.

The natural gully, which continues to cause significant water runoff is impacting properties at The Meadow in Polgooth, contributing to blocked drains and flooding. The CAT will explore alternative solutions for managing the water flow in this area.
