Visit to the Kresen Kernow Archive Wednesday 11th June regarding documents relating to Polgooth Village Institute, now Polgooth Village Hall.

Having checked the online catalogue no Deeds or Minutes, although there were minutes for the Polgooth WI and a restricted file and the Deputy Clerk requested these were made available for inspection.

The WI minutes were all around fund raising and trips, no mention of the Institute, except funds raised for it. The restricted file, which was restricted due to persons mentioned, a GDPR form had to be signed to ensure that I didn't divulge any personal data, as this is a criminal offence, any photographs taken of this file needed to be checked by the archivist to ensure no breach occurred.

The file contained a grant application for a rear extension to the Institute which (according to the application) was originally built in the 1930s in corrugated asbestos and the Parish Council had agreed to be Custodian

Trustee, this is dated 1989. The grant application had drawings of extension. It mentions conveyances dated 6.11.1970, 15.5.1973 and 28.11.1976. The grant application was successful, and a grand opening occurred in 1991.

There were some other interesting reads in this file but not relevant to finding the Deed.

The archivist checked her database and confirmed no minutes relating to Polgooth Village Institute or Polgooth Village Hall had ever been archived, nor the Deed.

Conclusion: No further forward on the Deed, but St Mewan Parish Council are Custodian Trustees **NOTED**
