<u>Draft Minutes of the Ordinary Council Meeting held on the 12th November 2025 commencing at 19.00 in St Marks</u>
<u>Church Hall</u>

Present: Cllr Vine (Chair), Cllr Mrs Tarbox, Cllr Mr Heyward, Cllr Watts, Cllr Rees- Webb, Cllr Davis, Cllr Richards, Cllr Spencer

Chairman Cllr Vine expressed the Council's thanks to Mrs Dudart and Mr Tolliday for their assistance with the Parish Council's footpath audit, which helped to secure funding from Cornwall Council for the renewal of the required signs and gates. The Clerk thanked Cllr Vine for his part in the footpath audit.

OC119/25 Public Participation

Mr Teague – Thanked Cllr Davis for providing feedback as the Parish Council's link representative. Discussions have taken place within the group regarding ways to bring the village hall out of its current state of limbo and make it fit for purpose for the village and surrounding area. It was noted that the hall's location presents challenges, including a steep access hill and limited parking. Can the council consider other options outlined as part of an alternative permit scheme for the Village Hall.

Cllr Vine requested that Mr Teague formally submit the group's proposals.

The clerk confirmed to Mr Teague that although The Dog Club and the Panto has a batch of permits there is no problem in suspending enforcement if there is a requirement for additional hall hire.

Mrs Jannaway thanked everyone who attended her husband's funeral and for the support given to him, which contributed to making his life so fulfilling and interesting. Cllr Vine expressed that David had been a pleasure to work with during his time on the Council.

The clerk thanked Mrs Jannaway for two boxes of biscuits given.

Mr Datson, Chair of the Polgooth Village Hall Committee, reported on progress regarding the proposed relocation of the village hall to The Goffin. He advised that two quotations, from separate company's had been received for site investigations, to examine both the upper and lower areas of the site, with a view to carrying out a full investigation following an initial assessment. The cost of the preliminary investigation is £2,140, and Mr Datson respectfully requested that the Parish Council consider match funding 50% of this amount.



Mr Datson circulated a copy of the quotation to members. Cllr Vine expressed that this matter would require a formal agenda item to discuss the exact proposed location, as there appear to be three potential options, and no map had been included in the earlier public consultation. Mr Datson, who had commissioned the original mining desktop report, confirmed that the central area of The Goffin (where test excavations were identified within a recent Desktop Study were carried out) appeared unaffected, while the topside remained stable. Cllr Vine also highlighted that certain areas of The Goffin contain established wildlife habitats and nature boxes, which must be protected. He suggested that a further round of public consultation, including more detailed plans, will be advisable. The Chair requested that Mr Datson email the desktop study report to the Clerk, who will circulate it to all members prior to the next meeting. Mr Datson added that he had undertaken research into similar village hall projects in Cornwall, including examples from Ladock and Trewoon.

Cllr Rees- Webb confirmed to Mr Tolliday that The Paddocks on St Stephens Rd, Sticker has planning approval, despite the Parish Council 's objections it was won on appeal.

Fly Tipping - Carne Hill, Penisker Road

After continually writing and speaking to Waste and Highways regarding Penisker Rd Carne Hill I have managed to get two signs put up in two different areas on that road warning ppl of the consequences of fly tipping in the area. I am also keeping up the pressure of the importance of a camera to catch the perpetrators, as this problem has been going on for far too long, around 10 years according to locals and the press.

Speeding - St Mewan Lane

I have spoken to the manager of Biffa waste vehicles since our last meeting, I reported the concerns of the speed these vehicles are doing while going through St Mewan Lane he would have liked a registration to direct it to the appropriate driver, I informed him that would be difficult. He has since had a meeting with all the drivers warning them to Ahed to the speed limit. He is investigating this matter further to ensure appropriate measures are taken to improve the safety of the residents of St Mewan. I have a name of the manager of Biffa Waste if needed.

New community Highways improvement Programme

You may have all seen the recent communication regarding the launch of the new community Highways programme, this will run for the duration of this administration to deliver local highways improvements. Each Cap will have a budget. Cornwall South has £75,189 per annum & each town & parish has been invited to submit one expression of interest.

I met with the local PCSO in Grampound with some of the local Parish Councillors and residents, they raised concerns regarding local crime.
