Please note, that today 23<sup>rd</sup> July 2025, clarifications have been made to the application and a slightly revised description for the proposal has now been set as:

'Works to trees subject to a Tree Preservation Order (C2/275) for G1 (1x Ash, 8x Oak and 1x multi-stem Sycamore), to remove dead wood throughout the tree group which is overhanging highway and gardens, and to coppice all 5 stems of the multi-stem Sycamore to ground level stump due to cavity and basal decay. Works intended to stop dead wood striking properties/highway, and to prevent Sycamore failure.'
