 Proposal Outline application for residential development of land including access for up to 20 dwellings.



Location Land West Of Sunny Hill Truro Road Sticker Cornwall **Applicant** MESSRS A & W LAKEMAN AND GEAKE **Grid Ref** 197493 / 50033

Re-consulted. Wide range of discussion took place, and associated documents were viewed together with the St Mewan Neighbourhood Development Plan and Design Code, and it was **RESOLVED** to **OBJECT.** Prop Cllr Richards, sec Cllr Mrs Tarbox. **Action: Clerk.**

Reasons as follows:-

St Mewan Parish Council recognises that 88 households within the Parish are in need of Affordable Housing. In line with this identified need, Policy 9 – Rural Exception Sites should be applied, requiring that 50% of any new development is allocated to as Affordable Housing, with a balanced mix of accommodation types suitable for all age groups.

The Parish Council fully supports the NHS's comments regarding the impact of the proposed development on primary healthcare provision. The development falls within an area where existing NHS services are under pressure, and any increase in population will further strain the system. However, a higher proportion of Affordable Housing is likely to result in new residents who are already registered with local healthcare providers, thereby minimising the additional impact on NHS funding requirements for expanding primary care services.

 Proposal Permission in Principle for single proposed dwelling (minimum 1 maximum 1)
 Location LAND AT KOJO HOUSE St Mewan St Austell PL26 7DT
 Applicant Mr Karl Ford

(Officer granted extension request from PC)

Discussion took place, and associated documents were viewed together with the St Mewan Neighbourhood Development Plan and Design Code, and it was **RESOLVED** to **OBJECT**. Prop Cllr Davis, sec Cllr Richards. Reasons as follows:-

The application site is in open countryside, it is not an infill scheme

It is not a rural exception scheme since it makes no provision to secure affordable housing

The shed on site is not and never has been a domestic dwelling

The application site is not classified as rounding off because it is not surrounded on at least two sides by existing built development and it would visually extend development into the open countryside

Observations: In order to access the facilities eg a convenience store in Polgooth with Trelowth, the nearest settlement which is approximately 2km from the site one would have to either use a car or undertake a dangerous walk along unlit roads with no pavements then cross the busy A390 which has a 60mph speed limit and does not have pedestrian crossing. One would need to travel further afield to access healthcare, education and employment.

Bus services are infrequent and in order to access a bus to Truro one would have to cross the A390 having first negotiated a narrow dark lane.

The limited range of local facilities, infrequency of bus services etc would mean that residents would be dependent upon the use of private car for most of the day-to-day journeys. This is at odd with the CEDPD Policy T1 which seeks to locate development where it would minimise the need for the use of private vehicles and instead encourage walking, cycling and public transport.
