Mr Richards is experiencing issues with people entering his land from Footpath 419/24/1. Cllr Mrs Padley advised there is very little the Parish Council can do with individuals walking on his land and suggests he erects signage.

Mrs Truscott is unhappy with people parking on a private tarmaced drive outside their property which accesses public footpath 419/24/1 and would like the Parish Council to erect a sign. Cllr Mrs Padley expressed it is not the responsibility of the Parish Council to provide signs for privately owned property. Concerns with overhanging trees and understands they border Northern Farm. Cllr Mrs Padley expressed this is the landowner's responsibility.

Mrs Neves and Mrs Truscott are having issues with children riding their bikes on the footpath and can the Parish Council erect a sign 'No Cycling'.

Mrs Neeves would like dog waste bins to be erected between St Mewan Lane and the school and Hembal Lane.
