Discussion took place on a request for a pump track in Trewoon and the resident would be happy to fundraise. Members confirmed there is plenty of space to accommodate and a more challenging track could be built. The clerk advised the committee, that currently there is no allocated reserves to match fund and it is quite possible the group would be willing to raise the total amount required. Members enquired re the balance of previous grant money from the parish council to Trewoon Recreational Grounds and Village Hall which hasn't been spent. The clerk confirmed this would resolved once the document has been finalised with the solicitors. Members proposed the track could go ahead in principle, however re-visit the proposal after winter monitoring of the newly built track in Polgooth. Prop Cllr Spencer, sec Cllr Mrs Padley.
