ROW10/19 Digital Mapping

- a) The Chairman reported the digital mapping is progressing with a final link required now with Vision ICT. The chairman asked the clerk about the content and it was suggested to link in the first instance all the Gold Footpaths.
- b) Cllr Holman explained the PSMA ordinance survey software updates received in the last 12 months. The clerk requests Cllr Holman queries the annual fee from PSMA and if this is an item required on an annual basis the fee needs to be incorporated into future budgets.
