RESOLVED to APPROVE the Council: -

- a) Delegates authority to the Clerk in consultation with the Chairman and Vice Chairman to take any actions necessary with associated expenditure to protect the interests of the community. Ensure council business continuity during the period of the pandemic Coronavirus during any period of restricted activity declared by the Government informed by consultation with the members of the council remotely/virtual when appropriate. The delegation does not extend to Council matters set in statute.
- b) To **APPROVE** the cancellation of all Council meetings thereafter this meeting including the suspension of the Annual Parish Assembly on the 8th April 2020 until further notice.

RESOLVED to **APPROVE** the following amendment to the Council's Financial Regulations Expenditure:

- 4.1 on revenue items may be authorised up to the amounts included for that class of expenditure in the approved budget. This authority is to be determined by:
 - the council for all items over £10000.00
 - a duly delegated committee of the council for items specified within the annual budget or:



- the Clerk/RFO in conjunction with Chairman of Council or Chairman of the appropriate committee, for any items below £10000.00 to facilitate the day to day operation of the council. The Clerk/RFO in conjunction with Chairman of Council or Chairman of the appropriate committee, for any emergency items below £10000.00
- 4.5 In cases of extreme risk to the delivery of council services, the clerk may authorise revenue expenditure on behalf of the council which in the clerk's judgement it is necessary to carry out. Such expenditure includes repair, replacement or other work, whether or not there is any budgetary provision for the expenditure, subject to a limit of £10000.00 The Clerk shall report such action to the chairman as soon as possible and to the council as soon as practicable thereafter.

The Chairman Cllr Kneller would like it recorded that the clerk is supporting three volunteer groups in the Parish and arranged printing of the first leaflet which was on Monday 16th March 2020 and delivered to all the electorate on Wednesday 18th March 2020. The clerk's focus at this time will be supporting the volunteer groups in the Parish, therefore it is noted it is likely the clerk's hours will go over budget.
