Short presentation by Cornwall Cllr Dick Cole on the 'White Paper' announced by Central Government. Cornwall Cllr Dick Cole's briefing note was previously circulated, he re-enforced the need to respond to the first consultation stage by the 1st October 2020. The Chairman invited members to raise questions. The Neighbourhood Plan will not be in sync with the Local Plan and consequently may not do what the public expect the Neighbourhood Development Plan to do. There is a high risk Neighbourhood Plans will be undermined.

Cllr Mrs Tarbox stresses the urgent need for parishioners to write to the MP Steve Double who is paid to represent his constituents and speak in parliament expressing the grave concerns of how Central Government will affect the future of planning in Cornwall.
